# Residential Tenancies Legal Information Program Year End Report June 2011

**Prepared for the Alberta Real Estate Foundation** 

### **Program Objectives**

The Residential Tenancies Legal Information Program encompassed five distinct objectives, with the focus group for 2010-2011 being low literacy Albertans and immigrants. The five objectives were identified as enhancing the legal knowledge and understanding of landlords and tenants in Alberta through:

- 1) developing and updating plain language resources about new and existing laws and regulations;
- 2) increasing the ability of landlords and tenants to find and effectively use current resources to educate themselves:
- 3) training intermediaries (people who work with the public, for example, teachers, social workers, and librarians) to efficiently access information about residential tenancy law;
- 4) responding to questions from the public about residential tenancy law; and
- 5) working with other organizations with similar goals to avoid duplication of resources and to maximize efficiency and expertise.

#### **Highlights**

- The demographic for the Residential Tenancies Legal Information Program 2010 2011 year was new Albertans. The main priorities were:
  - o to gather information
  - o conduct research
  - o make contacts
  - o determine appropriate resources for this audience
  - create print and digital resources

A resource guide, *Landlord and Tenant Law in Alberta: The Basics*, was developed to assist immigrant serving organizations assist new Albertans in understanding residential tenancy law in Alberta.

- Renting 101: A Guide for Students and First Time Renters continues to be a popular resource, and makes up over 40% of the material distribution. Renting 101 was revised this year and the second edition will be printed in the summer of 2011. We received \$3,500.00 from Service Alberta and an additional \$3,500.00 from AREF to assist with printing costs.
- Additional funding in the amount of \$4,095.24 was received from Service Alberta for the printing of
  the Seniors' Housing Series and the Sample Roommate Agreement for Alberta Renters. The
  Landlord and Tenant Board of Wood Buffalo also covered all travel expenses for the Coordinator's
  visit to Fort McMurray (\$1100). The Legal Resource Centre provided an estimated \$18,000 to
  provide clerical and management support, promotions, network access, material distribution and
  infrastructure.
- 4,121 items were distributed during the year, with the majority of the publications being ordered from the Legal Resource Centre's e-store.
- Two new publications, Foreclosure for Landlords and Tenants in Alberta and Foreclosure in Alberta, were developed in response to the increased number of reference questions received from tenants and landlords that are involved in the legal process of foreclosure. The publications are currently in review.
- Two sample agreements, the Sample Roommate Agreement for Alberta Renters and the Sample Room Rental Agreement for Alberta Renters, were developed as a guide for alternative housing arrangements. The agreement can be viewed online, printed and used by the public.

- The Program Coordinator conducted 31 information workshops to over 600 people, which is a substantial increase from the 5 workshops that were conducted the previous year. Workshops were held across Alberta, including sessions in Fort McMurray, Grande Prairie, Edmonton, Red Deer, Calgary, Lamont and Andrew; the feedback received from the audiences was overwhelmingly positive. The Regional Municipality of Wood Buffalo paid for all of the Program Coordinator's expenses for her to travel and conduct community presentations.
- Evaluations of presentations were done wherever possible. The charts below indicate the general feedback

#### **Training Sessions, Presentations, & Workshops**

The number of presentations and workshops increased substantially from previous years. In 2010-2011, 31 presentations and workshops were conducted across Alberta, up from 5 in the 2009-2010 year. Legal information was provided to over 600 people during these sessions, and feedback received from the audiences was overwhelming positive. Workshops were conducted in Red Deer, Fort McMurray, Grande Prairie, Edmonton, Calgary, Lamont and Andrew. PowerPoint presentations were developed for each session.

#### **Statistics**

Website User Statistics

An average of 798 people visited the site a day, which is an increase of 70 people visiting a day from last year. Interestingly, there has been a substantial increase in visitors to the site starting in 2011 and continuing. For example, in May and June 2011, the number of visits per day increased 30% in comparison to May and June 2010. We attribute this increase to the rural outreach that was undertaken this year. Over the course of the year, use of the website increased 9.7% from last year, for a total of 291,364 visits and over 1,380,000 page views. On average, each visitor goes to 4.76 pages when they visit the website, and the average amount of time each visitor spent on the website is 3:53. The bounce rate, which means the users who only visit one page of the website, is 32% which is an increase from last year.

Rural Albertans continue to be proportionally greater users of the site than people in Edmonton and Calgary who have access to other services.

#### Reference Statistics


Staff responded to 624 questions, which is a decrease of 14% from the previous year. Ultimately, our goal is to eliminate the need for a reference service at all, as the Program Coordinator's time is spent more effectively by developing new resources. Visitors to the website have increased, while reference questions received have decreased, illustrating that the increased number of publications and other materials presented on the website is providing people with the information they require. We also attribute the decrease in the number of reference questions to the increase in the number of workshops that were available this year.


Distribution of materials increased from the previous year, with 4,121 publications and 1, 602 bookmarks being distributed. All of the booklets are now available online in Adobe .pdf format, and can be printed by the user. Renting 101 continues to be the most popular resource, and made up 44% of the total distribution. We anticipate that distribution numbers will continue to increase for the second edition of Renting 101.


## **Priorities for 2011-2012**

Specifically for 2011-2012, we plan to:

- Provide 25-30 presentations to various target audiences
  - Distribute 5000 information items
  - Meet arising needs (e.g. in the last year, the roommate agreements and the foreclosure publication arose from an expressed need).
  - Review, update, and reprint major publications
  - Usability and technical study of the website and a plan for revitalizing the website using current design and technology practices.
  - General evaluation of the program's success
  - Continued committee work and networking with other providers.
  - Continue to respond to email gueries (600-700).
  - Increase promotional activities to targeted groups.
  - Ensure that the AREF contribution is recognized.
  - Set up a communication tool that will help get the message out to key stakeholders
  - Continue to respond to requests from schools, seniors, and the public for information
  - Review online resources for the ease of retrieval via PDAs such as Blackberrys, iPhones, and iPods.
